Outagamie County

Outagamie County, in collaboration with the Village of Hortonville, have contracted with McMahon Associates to develop plans to improve County Trunk Highway (CTH) JJ (former State Highway 15) between Industrial Park Ave and Greendale Rd. The proposed project will replace the existing pavement and rehabilitate the highway to meet current standards and improve multimodal accommodations. The bridge over Black Otter Creek is also planned to be reconstructed. The highway is anticipated to remain as a two-lane facility. Construction is currently scheduled as early as 2026.

The purpose of this letter is to inform you of an upcoming Public Involvement Meeting to discuss the proposed improvements. The meeting will be held at the **Village of Hortonville Municipal Building, 527 N Nash St**, on **Tuesday, March 5, 2024 from 6:00 pm to 7:00 pm**. The meeting will be an open-house format and consist of a brief formal presentation followed by a question and answer session.

The intent of this meeting is to explain the concepts and possible impacts of the proposed improvements. As a project stakeholder, your input and feedback is important to the design process. Staff from McMahon, the Village, and Outagamie County will be present to provide information and answer your questions.
