Single Trip Permit

Maximum size and weight for which a single trip permit may be granted:

Length – Single vehicle 50 ft. Mobile Crane 60 ft.

<u>Weight Limitations</u>	<u>Gross Weight in Pounds</u>
Steering Axle	20,000
Any Other Axle	35,000
Additional weight limitations may be imposed by route.	

The overall length, width and height of other loads depends on type of load.

If the spacing between adjacent axles is less than 42 inches, the axle can carry no more than a single axle.

Insurance Requirements

The permittee shall have at least the following insurance coverage in full force and effect on the vehicle and load designated in the permit while operating on the public highway.

GROUP A - Applies when the permitted load does not exceed 12 feet in width, 13.5 feet in height, or 100 feet in length and does not exceed statutory gross weight limits by more than 25%.

GROUP B - Applies when the permitted load exceeds the size and weight limitations in Group A.

Upon request will present the County with a valid certificate of insurance and/or a certified copy of the applicable insurance policies.

2. Please note that payments tendered through the portal will be assessed a one-time convenience fee based on the total amount due. Convenience fees are in addition to the amount(s) owed.
