Apple AOC Grant (Freedom District)-All these projects are required to have archaeological survey done before construction:

-PRS design is nearly complete- VanAsten Rd, similar design is also planned for N. of Cty Rd UU (will bring maps & preliminary design plans as we haven't discussed these yet)

-Freedom 2-stage west of Fox Valley Golf Club

GLRI Riparian Grant:

-Fox Streambank/Two-Stage (Freedom)- currently going back and forth with DNR permitting needed- may need to modify plans based on final decisions from DNR
