#757 – Center – Grand Chute Drainage District
Annual Meeting Minutes – October 4, 2023

President Kramer called the meeting to order at 7:00 p.m. at the Town of Grand Chute Town Hall. He introduced the Outagamie County Drainage Board members. Present: Al Kramer, Greg Nettekoven, Jason Van Eperen, Mike Van Asten, Gerald Vander Heiden

Also present: Nancy Christensen, Administrative Assistant; Greg Baneck, Land Conservation Department; Others present: Wayne Stingle, Brian Ebbin, Nicole Price, Heath Lawson, Bob Heimann, Jerry Shown, Libby Kramer, Paul Flunker, Katie Hasland, Richard Kierzek

Kramer informed those present the Board meets every first Tuesday of the month at 8:30 a.m. at the Town of Osborn, W3389 County Road EE, Seymour. Any concerns may come to this meeting and bring them before the Board or contact any member at any time. Minutes and agendas are posted on the Outagamie County website under the Land Conservation Department.

Minutes of the September 28, 2022 minutes –

Bob Heimann moved, seconded by Wayne Stingle to approve the September 28, 2022 minutes as presented. Motion carried.

Presentation of projects completed and future projects –

Greg Baneck, LCD, gave an overview of the current district.

Projects to be completed are: Western section of district: district drain tile replacement of 1442' from Beacon Hills Subdivision on Mayflower to Edgewood Drive – estimated cost \$36,000; annual spraying in various areas; 1,806' of tree removal from McCarthy Road to Casaloma Drive estimated cost \$30,000 - \$40,000; various dredging projects - 3,406', estimated cost \$34,000; Central section: Bubolz to "O" individual items needs to be addressed on main ditch including culvert replacements and crossing repairs. Outlet at County Road "O" – spraying and general maintenance; failing culvert by TML Auto; landowner bridge by Edgewood needs to be addressed.

Brian Ebbin, N2615 State Road 47, reported the culvert on end of Broadway Drive is blocked.

Wayne Stingle, N2735 State Road 47, stated the cleanout on his property has not been done. Kramer stated the cattails will be sprayed and the cleanout will be addressed.

Libby Kramer, 3836 N Cobble Creek Drive, asked if all the trees need to be removed along the legal drain. Kramer stated the property owners will be directly contacted to discuss what needs to be completed on their property. The Board will work with the property owners but maintenance access is required to the legal drain.

NRCS Grant – Kramer reported an application applying for a grant is in the process of being made. The grant is through the NRCS Watershed Program for Federal assistance with large-scale watershed planning and water resource projection implementation. The primary watershed problems would appear to be water quality and drainage issues. The municipalities of Grand Chute, Greenville, Center, Bovina, Ellington and Appleton would be involved in the project.

2022-2023 Financial Report

Christensen reviewed the 2022 Financial Report. The ending 2022 fund balance was \$85,223 which was carried over to 2023. Revenues received January through September 30, 2023 was \$68,288, total revenue \$153,511. Expenditures January through September 30, 2023 were \$5,801 with a remaining balance as of 9-30-23 of \$147,710.

Budgeted future expenses: McCarthy Road to Casaloma Drive – tree removal and dredging \$75,000

2023 Assessment Rate payable in 2024 –

Discussion was held on completing a re-assessment of the drainage district for special assessment purposes. The majority of this district is commercial and industrial usage and the current special assessment rate does not address the

land usage. The Board is looking at implementing an ERU rate as the Village of Greenville and Town of Grand Chute currently use this method for other special assessments.

Bob Heimann moved, seconded Jerry Shown, to recommend to the Board the special assessment rate remain at \$4.00 per acre and \$40 minimum for 10 acres or less. Motion carried.

Richard Kierzek, 4956 W Woods Creek Lane, requested the Board look as the ditch north of his property as the water does not drain correctly.

The 2024 Annual meeting will be held around the same time.

Kierzek moved, seconded by Wayne Stingle to adjourn at 7:40 p.m.
