7                   BE IT RESOLVED, that the following be and is hereby declared the tax levy for 2017, collected  
8                   in 2018:

1.	There is levied upon the taxable property of Outagamie County the sum of for State Tax (Forestry purposes).	<u>N/A – 2018 Budget</u>
2.	There is levied upon the taxable property of Outagamie County the sum of for debt service, all bonds, and notes legally required.	<u>\$10,684,705.00</u>
3.	There is levied upon the taxable property of Outagamie County the sum of for libraries. The City of Appleton, the City of Kaukauna, the City of New London-1 <sup>st</sup> and 2 <sup>nd</sup> Ward, the City of Seymour, and the Villages of Black Creek, Hortonville, Kimberly, Little Chute, and Shiocton are not included.	<u>\$1,780,017.00</u>
4.	There is levied upon the taxable property of Outagamie County the sum of for public health services. The City of Appleton is not included.	<u>\$1,248,871.00</u>
5.	There is levied upon the taxable property of Outagamie County the sum of for County and Town Aid Bridges, excluding the City of New London-1 <sup>st</sup> and 2 <sup>nd</sup> Ward; the City of Seymour; the City of Appleton; the City of Kaukauna; Village of Howard; the Village of Shiocton; and the Village of Wrightstown.	<u>\$ 75,000.00</u>
6.	There is levied upon the taxable property of Outagamie County the sum of for all other services provided.	<u>\$56,439,035.00</u>
