Agreement Terms and Conditions

This agreement is entered into by and between the Wisconsin Department of Natural Resources (DNR), and the cooperator named above for the purpose of applying wildlife management practices on the land. As specified in this agreement, the cooperating partners agree:

Section I (Applies to all cooperators)

1. The cooperator is an independent contractor for all purposes, including worker's compensation, and is not an employee or agent of the WDNR. The cooperator shall at all times comply with federal, state, and local laws, ordinances, and regulations in effect during the period of this agreement.

Section II (Applies only to seeder cooperators)

2. The cooperator agrees to pay for seeder rental at the rate agreed upon for use of seeder equipment and shall:
3. The cooperator agrees to release the DNR and its agents from all liability, claims, and costs arising from use, operation, or transportation of the Brillion, Truax, Tye and/or other seeder pursuant to this agreement.
4. The cooperator agrees to provide transportation of the machine to and from the site of planting.
5. The cooperator agrees to pay the DNR the cost of repairing the machine in the event it is damaged through the fault or neglect of the cooperator. The cooperator is responsible for any damage to the seeder through fault or neglect. Damage done to the brushes when the seeder is backed-up while in the planting position is considered neglect by the cooperator. The cooperator is NOT to do any repairs to the seeder. If problems occur, contact the Wildlife Biologist or Technician listed as Seeder Contact in this agreement. If the DNR repairs the seeder, the cooperator will NOT be charged for labor, only damaged parts. If a private contractor makes repairs labor will be included. The DNR will pay the cost of normal wear and maintenance work on the seeder.

Agreement Terms and Conditions, cont.

6. The cooperator agrees to comply with guidelines established for the seeder operation in the attached and hereby incorporated document titled PRAIRIE SEEDER OPERATING INSTRUCTIONS.

Section III (Applies only if the DNR provides the entire seeding operation)

7. The cooperator agrees to pay the DNR for seeding at the rate per acre agreed upon specified when the DNR seeds the property, as listed above.

8. The DNR agrees to provide the entire seeding operation, including labor, seeder, and tractor, excluding seed.
