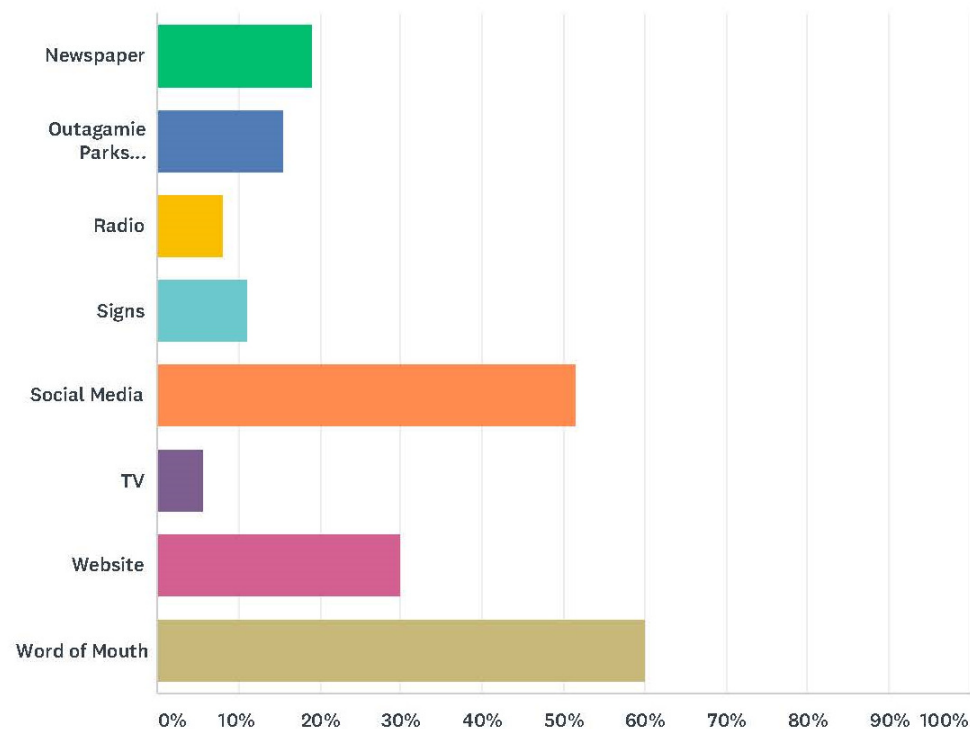

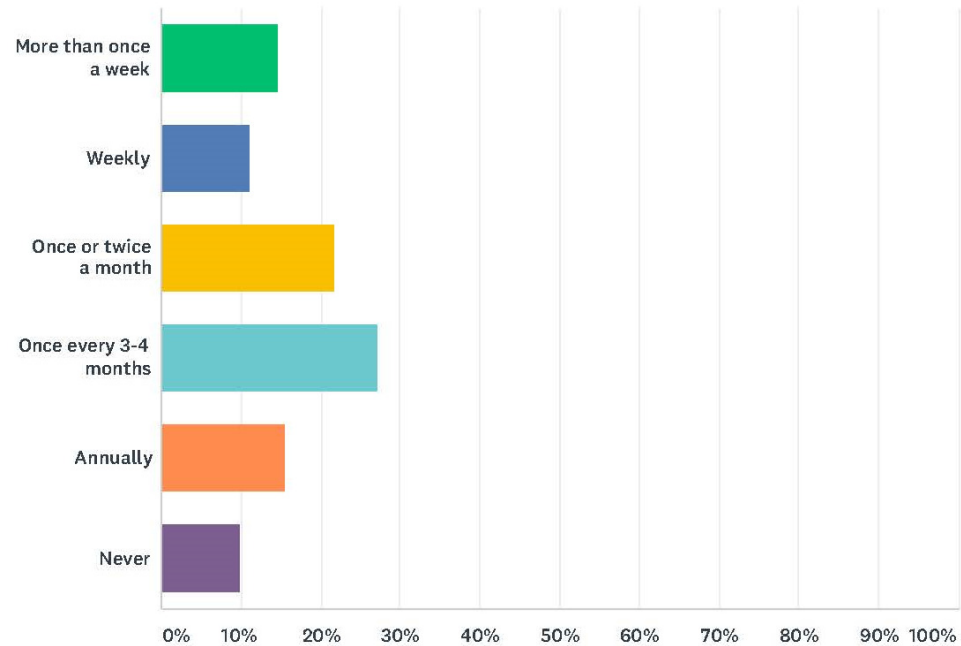

How often have you visited Plamann Park in the past 12 months?

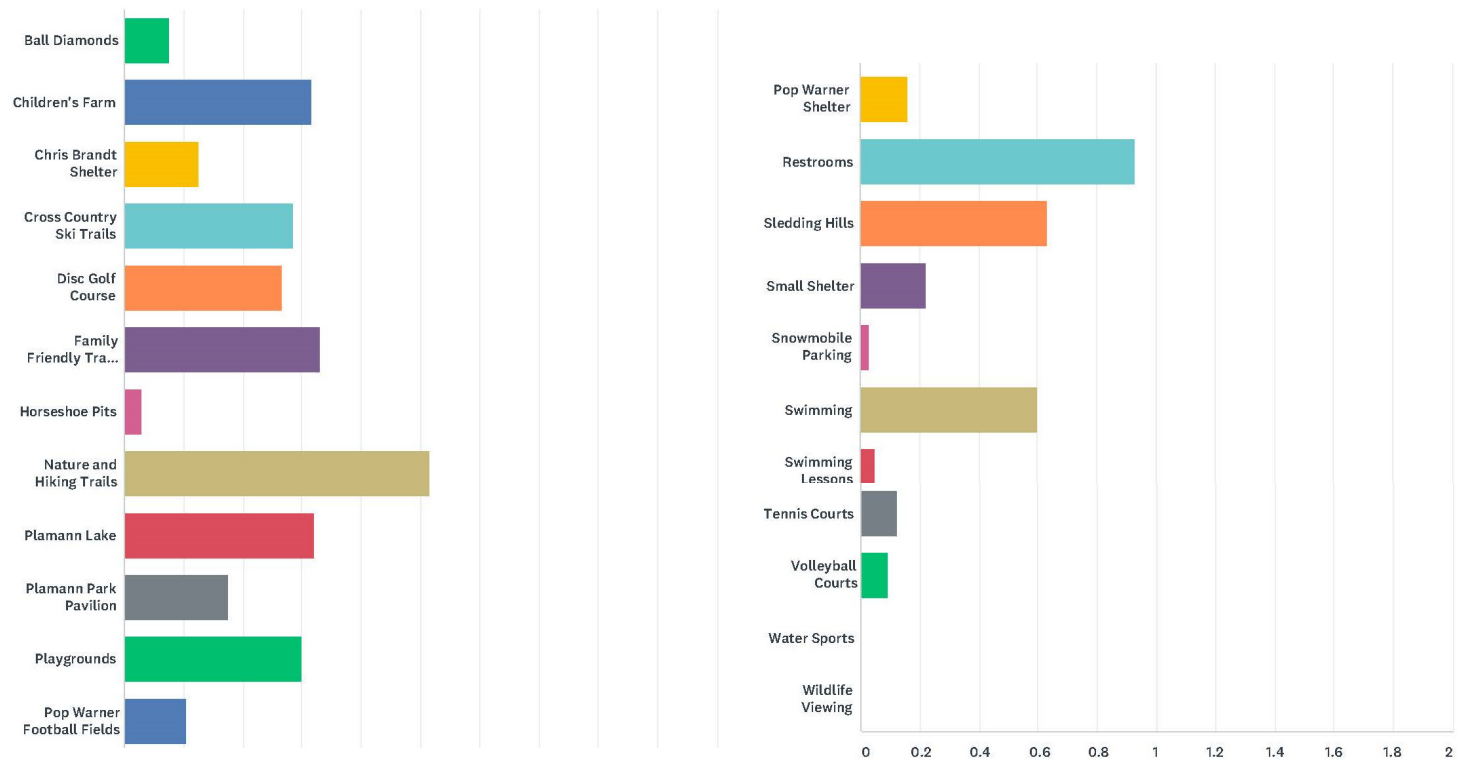

How often do you use the following facilities?

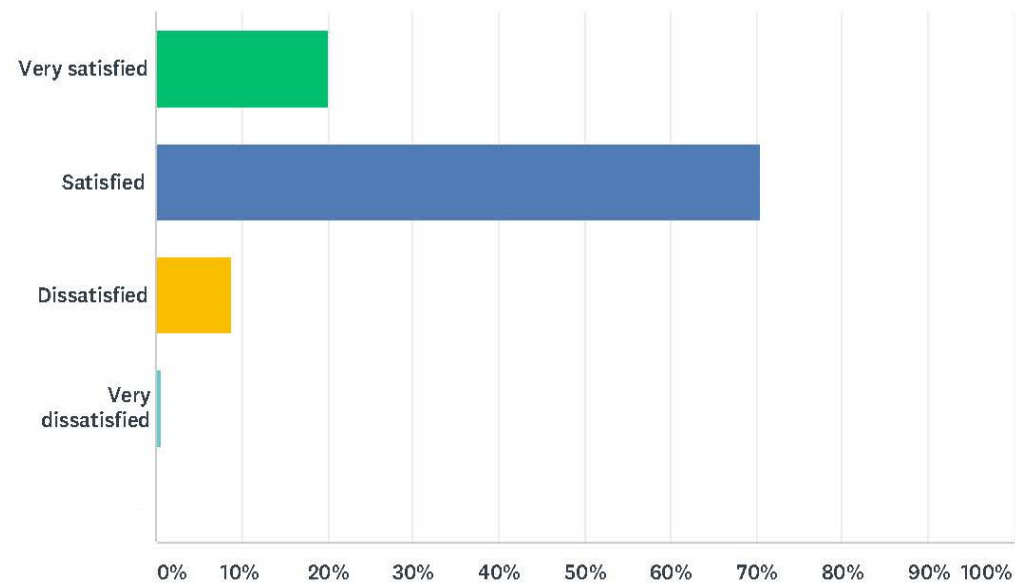

What is your level of satisfaction with the overall condition of Plamann Park?

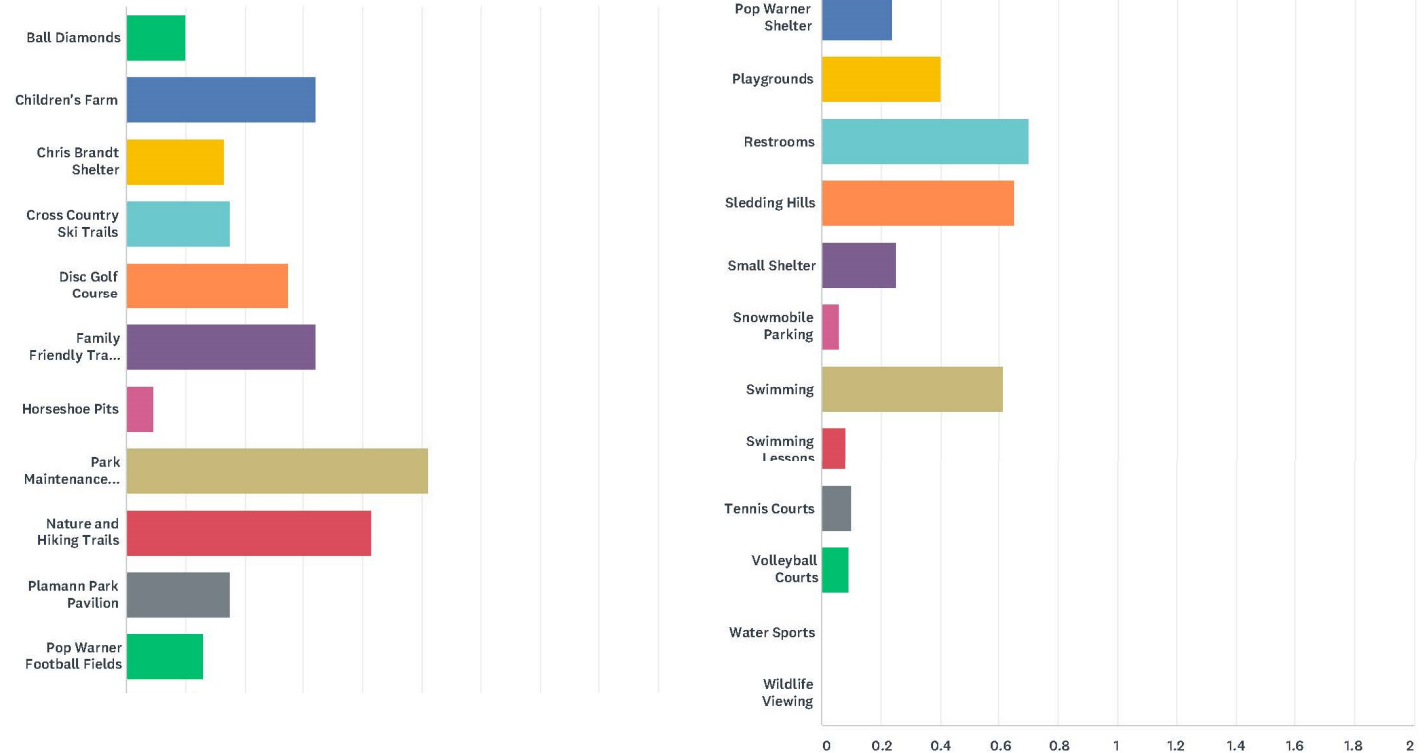

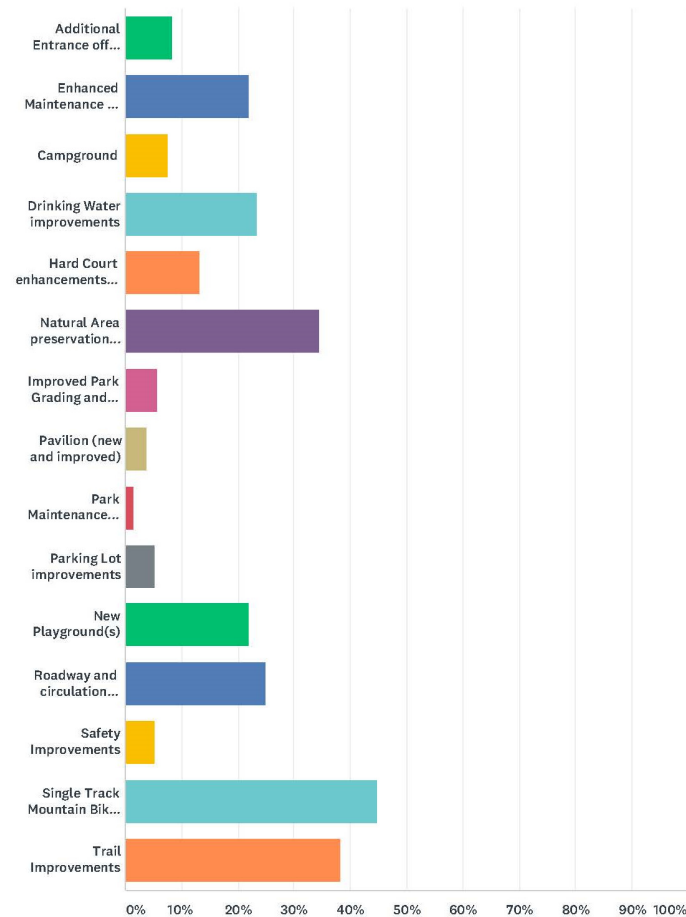

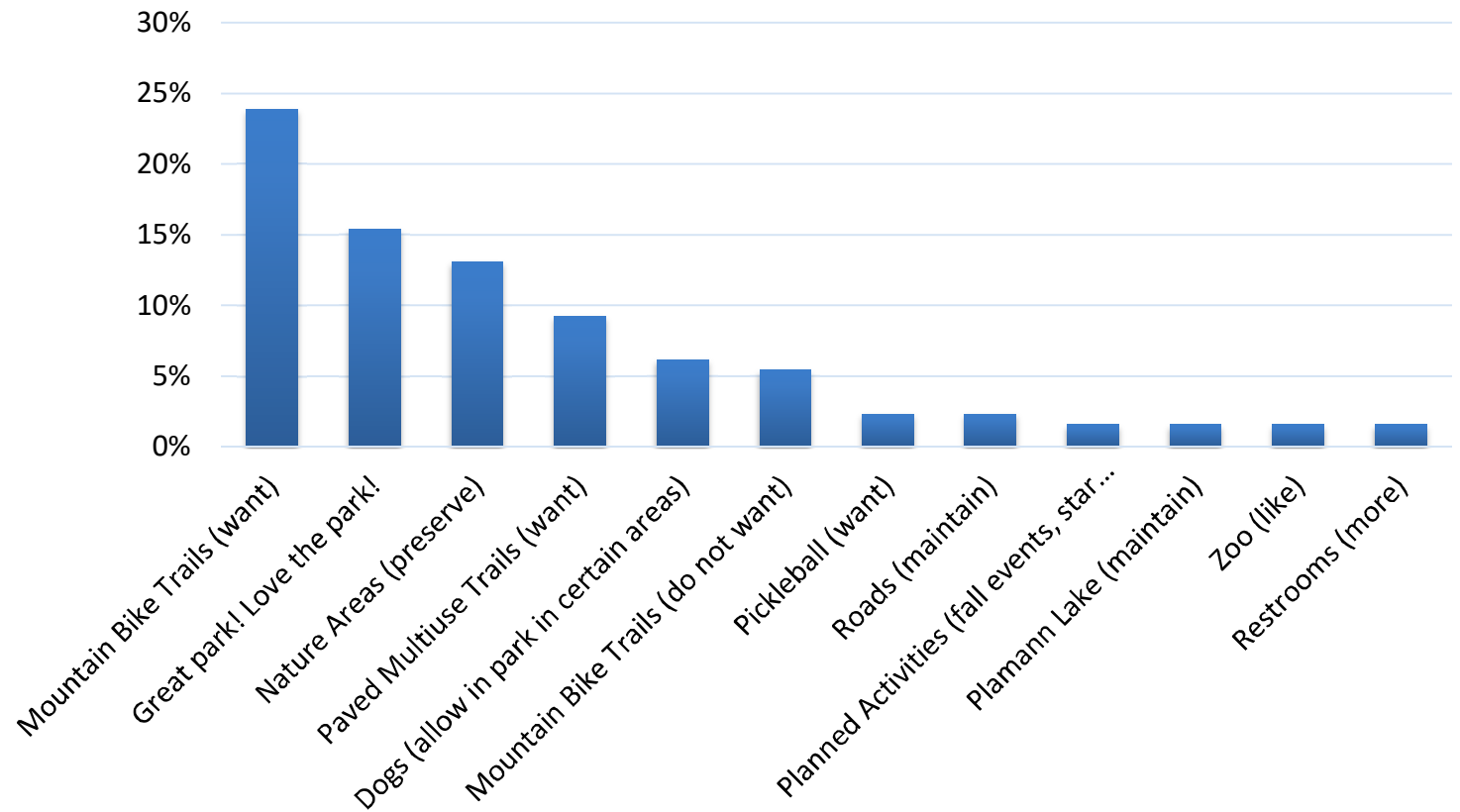
