
The Board meets pursuant to adjournment, and is called to order by Chairperson Nooyen at 7:00 p.m. by teleconference.

 - A. Ordinance No. Z-7—2021-22 – Agriculture, Extension Education, Zoning and Land Conservation Committee. Adopt the petition of FVT Enterprises LLC, dba Fox Valley Truck, owner, to rezone parcel 101081000, 8.7 acres, from AGD General Agriculture District to IND Industrial District in the Town of Grand Chute, as noted on the attachments.
 - B. Ordinance No. Z-8—2021-22 – Agriculture, Extension Education, Zoning and Land Conservation Committee. Adopt the petition of Eric and Elizabeth Kositzke, owner, to rezone a portion of parcel 040023800, 16 acres, from AGD General Agriculture District to CL Local Commercial District in the Town of Center, as noted on the attachments.


- C. Resolution No. 59—2021-22 – Agriculture, Extension Education, Zoning and Land Conservation Committee. Approve the UWM-Extension line item transfer of \$6,000 from Travel/Training to Capital Outlay for an audio/visual upgrade to Meeting Rooms 1 and 2 at the UWM-Extension Office, as detailed on the attached fiscal note.
- D. Resolution No. 60—2021-22 – Finance Committee. Approve the General Fund line item transfer of \$721,448 from the Committed – Sales Tax Fund Balance Committed Sales Tax to the Unassigned Fund Balance Unassigned; increase the following line items by \$1,990,000 each: General Fund Surplus, Fund Balance Applied; General Fund Revenues, Transfer Out; 2021 Capital Projects Fund, Transfer In; Parks Pavilion Non Debt, Capital Outlay; and decreasing the following line items by \$1,990,000 each: 2021 GO Debt Capital Projects Fund, Debt/Note Proceeds; Parks Pavilion – Debt, Capital Outlay; to potentially eliminate the need for bonding in 2021 for the Plamann Park Pavilion Project, as detailed on the attached fiscal note and Attachment A.
- E. Resolution No. 61—2021-22 – Finance Committee. Deny the claim submitted by Heather Bakken, placed on file in the County Clerk Office, and that no action on this claim may be brought against the County or any of its officers, officials, agents, or employees after six months from the date of service of this notice.
- F. Resolution No. 62—2021-22 – Highway, Recycling and Solid Waste Committee. Authorize and approve the County Recycling and Solid Waste Department to accept and expend grant funding of \$50,000 from Foodservice Packaging Institute for the acquisition of a Polystyrene Densifying Machine, and increase the line items for the Recycling and Solid Waste Transfer Station/Internal Capital Outlay and Transfer Station/Internal Miscellaneous Revenues by \$50,000 each, as noted on the attached fiscal note.
- G. Resolution No. 63—2021-22 – Legislative/Audit and Human Resources Committee. Grant the courts the ability to hire as many bailiff positions as needed to support Circuit Court Judges when jury trials occur and by performing services to meet the operational needs of the courts during trials, and require that costs for hiring bailiff positions are included in the adopted budget.
- H. Resolution No. 64—2021-22 – Property, Airport, Recreation and Economic Development Committee. Grant We Energies an easement for the area described as a strip of land twelve (12) feet in width, being part of Outagamie County's land located in the Northeast $\frac{1}{4}$ of Section 1, Township 21 North, Range 17 East, City of Appleton; said land is shown in the attached Distribution Easement Underground and Temporary Exhibit "A".
- I. Resolution No. 65—2021-22 – Finance Committee. Support the attached City of Appleton Project Plan Amendment #1 to Tax Incremental District (TID) No. 12, dated June 29, 2021, and recommend that the representative of Outagamie County on the City of Appleton TID Board of Review vote in favor of the City of Appleton's TID No. 12 Project Plan Amendment #1.
- J. Resolution No. 66—2021-22 – Legislative/Audit and Human Resources Committee. Approve the Recruitment and Retention Specialist position reclassification request for Brewster Village, with no 2021 budget adjustment necessary, included on the attached fiscal note, Position Classification/Grade Change Form, Job Description, and Table of Organization.

- K. Resolution No. 67—2021-22 – Legislative/Audit and Human Resources Committee. Authorize and approve the Tentative Supervisory District Plan for Outagamie County apportioned into 36 supervisory districts as noted on the attached Recommended – Tentative Supervisory District Plan.
- L. Resolution No. 68—2021-22 – Finance Committee. Support the attached City of Appleton Project Plan Amendment #2 to Tax Incremental District (TID) No. 3, dated June 29, 2021, and recommend that the representative of Outagamie County on the City of Appleton TID Board of Review vote in favor of the City of Appleton's TID No. 3 Project Plan Amendment #2.
- M. Resolution No. 69—2021-22 – Property, Airport, Recreation and Economic Development Committee.
