The Outagamie County Highway Department has plans to replace the County KK bridge over Kankapot Creek in the Town of Buchanan in the near future. The currently proposed plan is to replace the structure and improve visibility along CTH KK by raising the roadway and improving the vertical profile approaching the bridge site.

Westbrook Associated Engineers, Inc. has been hired to perform the engineering and survey work associated with this project and you will notice survey crews in the area within the next few weeks.

After the initial survey and preliminary plans have been prepared, the information will be shared and property owners will be invited to review the plans and ask any questions regarding this project. Through the public involvement process and your input we are able to develop a project that will suit the needs of the area and provide a safe and efficient facility for both the residents and area motorists.
