AMERICAN RESCUE PLAN ACT OF 2021

Public Law 117-2

- **Signed into law March 11, 2021**
- **Includes State & Local Fiscal Recovery Funds (SLFRF)**, providing direct federal support to state and local governments to respond and recover from the health and economic impacts of the pandemic
- **Administered by U.S. Department of the Treasury**
- **Funds distributed in two tranches**, first in May, 2021, second no sooner than one year after the first distribution
- **Funds must be obligated by Dec. 31, 2024 and expended by Dec. 31, 2026**

ARPA - STATE & LOCAL FISCAL RECOVERY FUNDS

ELIGIBLE USES

- **Replace lost public sector revenue**, using this funding to provide government services up to the amount of revenue lost due to the pandemic (*up to \$10M or per formula*)
- **Respond to the far-reaching public health and negative economic impacts of the pandemic**, by supporting the health of communities, and helping households, small businesses, impacted industries, nonprofits, and the public sector recover from economic impacts
- **Provide premium pay for essential workers**, offering additional support to those who have and will bear the greatest health risks because of their service in critical sectors
- **Invest in water, sewer, and broadband infrastructure**, making necessary investments to improve access to clean drinking water, to support vital wastewater and stormwater infrastructure, and to expand affordable access to broadband internet

- Engage a broad swath of community stakeholders, with a particular focus on those most harmed by COVID-19.
- Implementation is targeted, delivered efficiently and equitably, and structured in a fiscally responsible manner to ensure long term financial obligations are accounted for and burdens on future/ongoing county operating costs are mitigated.
 - Eg. Investing in assets that can minimize or reduce future year's resources.
- Evidence based decision making, and tracking of programmatic and community outcomes.
- Address critical/immediate needs, and invest in efforts that ensure long term economic and community health.
- Collaboration and creative partnerships within the county and amongst community partners.
- Compliance with federal guidance & oversight requirements, providing transparent accountability for internal & external stakeholders.

Assessment & Next Steps

Based on evaluation of the county's stakeholder & community engagement, and UW-O survey results, we have identified the following major issues/focus areas as it relates to Outagamie County's COVID-19 response & recovery:

- County-wide access to high speed, high capacity, and affordable internet.
- Workforce Development: recruitment/retention; training/education
- Economic Development: Business Assistance, Tourism Recovery
- Childcare & Early Childhood Development
- Mental Health
- Affordable Housing
- Food Access & Security
- Consistent Messaging & Communication
- Fiscal Impacts: Inflation and lost sales tax/other revenues
- Access to COVID-19 rapid testing

In terms of next steps, additional research, evaluation, and discussion will be required within county administration, amongst community partners, Finance Committee, County Board to determine if and how Outagamie County's ARPA funding could best be used to address the issues above. Staff will continue to report back on efforts to the Finance Committee as these efforts begin to take shape.



As a part of Mental Health Awareness Month, County Executive, Thomas M. Nelson, was honored to tour Us 2 Behavioral Health Care's building Monday to see first-hand how they are utilizing the funds they received from Outagamie County through the American Rescue Plan to bolster their Dialectal Behavioral Therapy (DBT) program.

DBT was originally developed to treat borderline personality disorder but is now widely used to treat individuals with severe emotional instability, self-harming activities, and suicidal behaviors. Borderline personality disorder affects 5.7% of the population, which is 20% of all mental health patients. These individuals have a suicide rate 50 times that of the general population. Thomas M. Nelson, "It was wonderful to see how the work their team is doing is helping our community strengthen our ability to address mental health care treatment options in our region."


