


- A. Ordinance No. Z-7—2022-23 – Agriculture, Extension Education, Zoning and Land Conservation Committee. Approve the amendment to the Outagamie County Comprehensive Plan, Volume 2: Action Plan, Future Land Use Maps 18, 21, 31 and 36, as reflected in the review of Exhibit 1.
- B. Ordinance No. Z-8—2022-23 – Agriculture, Extension Education, Zoning and Land Conservation Committee. Adopt the petition of Paul Robert Gardener, property owner, to rezone parcel 190038300, two acres, from AED-Exclusive Agriculture District to AGD-General Agriculture District in the Town of Seymour, as detailed on the attached review and map.
