## Drunk Driving Offenders...

### This court has ordered you to attend an Impact Panel.

This is a condition of your court order. Your presence is required by the State of Wisconsin, Statute 346.65 (2g) (b) and (2i), as a part of your conviction as a drunk driving offender.

***Failure to attend may result in the finding of contempt from the Court.***

## The Problem...

### and the Approach...

Even with tougher laws and attitude changes in recent years, alcohol and other drug impaired drivers continue to kill and injure.

Education and stiffer penalties may alter drinking patterns for some people. For others, the reality of drunk driving has not “hit home”. These people may benefit from a personal approach. A message delivered in person—from the hearts and voices of those who have lived through the trauma of impaired driving.

These panels of people share their stories of pain and loss with drunk driving offenders and individuals who appear in need of understanding the results of impaired driving.

The goal of the Impact Panel is not to blame or judge, but rather to reach the audience on an emotional level; a level that citations, fines and incarceration may not touch. The purpose of the Impact Panels is to reduce the rate of repeat drinking/impaired driving of those who attend this program.

Listening to the personal accounts of people who have lived to tell about the grief and despair that occurs “after the crash” can help all drivers understand the dangers and consequences of drunk driving. At the same time, panel participants often view their participation as a healing experience.

**“Speaking at panels provides me a forum to warn people about the repercussions of drinking & driving. I try and give someone a story; a name & a face, so if they’re in a situation to prevent themselves or someone else from getting behind the wheel drunk, they have a tool.”**

*Drunk driver struck and dragged him 6 blocks underneath the vehicle. Family was contacted to make final arrangement due to the severity of the injuries. Lengthy rehabilitation...and still in progress.*

**Outagamie County**—40% of the traffic fatalities (deaths) the past years are committed by those under the influence of alcohol or other drugs.

**Wisconsin**—One person is killed or injured in an alcohol related crash approximately every 88 minutes.
