

10. NEW BUSINESS
  - A. Ordinance Z-11—2022-23 – Agriculture, Extension Education, Zoning and Land Conservation Committee. Approve the amended County Code of Ordinances to include Illicit Discharge Detection and Elimination Chapter 43-1 through 43-19, as noted on the ordinance and outlined in Attachment A.
  - B. Ordinance Z-12—2022-23 – Agriculture, Extension Education, Zoning, and Land Conservation Committee. Approve to adopt the petition of Scott J. Doucette, property owner, to rezone parcel 160049000, two acres, from AED-Exclusive Agriculture District to AGD-General Agriculture District in the Town of Maple Creek, as noted on the ordinance and attachments.
  - C. Resolution No. 141—2022-23 – Finance Committee. Approve the financing plan for the Dreamville Kaukauna Apartments Project and the issuance of tax-exempt Bonds in an amount not to exceed \$55,000,000 by the Public Financing Authority, as noted on the resolution and attachments.

- D. Resolution No. 142—2022-23 – Property, Airport, Recreation and Economic Development Committee. Approve to grant ANR Pipeline a permanent easement along the Wiouwash State Trail (as noted on the resolution and attachments) and increase the Parks Department Plamann Park line items of Miscellaneous Revenue and Purchased Services by \$1,800 each, as noted on the attached fiscal note.
- E. Resolution No. 143—2022-23 – Public Safety Committee. Approve of the Emergency Management Department to accept and expend the Hazardous Materials Emergency Preparedness Grant of \$11,900 and increase the EM Grants line items of Intergovernmental Revenues and Purchased Services by \$11,900 each, as noted on the attached fiscal note.
- F. Resolution No. 144—2022-23 – Property, Airport, Recreation and Economic Development Committee. Approve to authorize granting We Energies an easement for the area described as strips of land varying in width being part of a parcel of land as shown on Certified Survey Map No. 1477, recorded in the Outagamie County Register of Deeds Office, and being a part of the East ½ of the Northeast ¼ of Section 26, Township 21 North, Range 16 East, Village of Greenville, as shown on the attachments.
