

**NOTICE OF PUBLIC HEARING
FOR ANNEXATION OF BENEFITED LANDS

TO WHOM IT MAY CONCERN:

The Outagamie County Drainage Board will hold a public hearing on Thursday, October 5, 2023 at 7:00 p.m. at the Town of Freedom Town Hall, W2004 County Road "S", Freedom, Wisconsin, at 7:00 p.m. to consider the petition to annex lands into the Freedom Drainage District.

Any owner of lands sought to be annexed may object to the petition at the hearing thereon and show cause why their lands should not be brought into the district and assessed.
